## ANNUAL LETTER FROM THE BISHOP

God's grace, peace, and hope be with you through our Savior, Jesus Christ.

In a normal year, I would use this report to highlight the many ways the Synod partners with your congregation to bring good news to your communities. 2020 was hardly a normal year.

Like your congregation, the synod needed to adapt quickly due to the threat of COVID-19, to cancel some programs, introduce new events, and modify most everything else. I have been amazed by the innovation and hard work of congregational leaders. I want – and encourage you as well – to speak a word of deep thanks to leaders for all that has been asked of them to hold our communities together and foster their flourishing.

Shortly after lockdown restrictions began in March, synod leaders led training sessions on online worship and pastoral care, as well as conversations on the question of Holy Communion as part of distance worship. In April, our Synod Treasurer and Secretary led two sessions on applying for PPP loans. In May, we were privileged to host Dr. Michael Osterholm for a presentation which drew 400 pastors, bishops, and leaders; as well as 100,000 viewers afterwards. We gave over \$46,000 in Imagination Grants to 25 congregations to strengthen their online worship presence. This fall, we gathered leaders for a well-received conversation on creative ways to celebrate Christmas. The synod staff provided worship services in May, July, and December, giving congregational leaders a much-needed respite.

Yes, 2020 was hardly a normal year. On May 25, 2020, the killing of George Floyd lifted the veil once again on the pandemic of systemic racism that infects our world. Churches near the killing and the uprising turned on a dime to address the immediate needs, supported by partner congregations throughout the synod. Clergy marched in silence led by AME Presiding Elder Stacy Smith. The Minnesota Council of Churches – which includes all six ELCA synods – voted unanimously to support a multi-year process "Dismantling the Structures and Repairing the Damage of Racism in Minnesota." The synod's new racial justice web page (mpls-synod.org/outreach/racial-justice) provides key information for congregations to deepen their work for justice, including the new Center for Leadership and Neighborhood Engagement, led by Rev. Kelly Chatman.

In addition to these efforts, we continue our essential and ongoing work of supporting leaders and fostering congregational vitality. We are blessed with over 700 rostered leaders, 325 serving in calls and 377 retired. We work hard so the church has the loving, faithful, and theologically well-formed ministers it needs. In 2020, we supported 67 persons preparing to become deacons or pastors.

## **ANNUAL LETTER FROM THE BISHOP** (CONTINUED)

In September, we were honored to receive a Lilly Grant that will support congregational cohorts committed to deepening their faith and neighboring practices. This month, we welcome Rev. Norma Malfatti as Director of Evangelical Mission who will promote our work in starting new congregations and accompanying our strategic ministries.

Our monthly conference meetings and other synod gatherings have revealed a real hunger among leaders to stay connected, learn from each other, and discern best practices for ministry in these times. We are honored and humbled by the calling to serve as convener of such holy conversations.

It is the generosity of congregations like yours that make the synod's work possible. Thank you! We seek to be careful stewards of every gift. With the PPP loan, which we pray will be forgiven, we hope to end our FY2020 year budget without dipping deeply into reserves.

I conclude this annual report with a word of deep gratitude for the privilege of serving as your bishop. And, I look forward to January 2022, when we can once again worship and gather *in person* – with hugs and handshakes and singing.

## **PASTOR REPORT**

## Sue Olson

Congratulations on enduring faithfully through 2020. We began 2020 with great hopes and dreams for our future. We held visioning meetings and had a structural engineer tour our facilities and make recommendations. We were on our way to restructure the use of our buildings and propose upgrades and construction. The enthusiasm was building. Our church council held an exciting full day retreat at the Erickson farm filled with plans and dreams. By the end of the day, however, we had determined that the best way to protect those we loved was to close the church building. It was a tearful departure that changed the way we did everything.

Staff began working from home; meetings were held over Zoom. Worship services were recorded from our homes on our phones. There was strong advice from the Bishop's office that we not do communion virtually. (We broke the rules and did it anyway; they later changed their minds) I wrote a note to every household encouraging them. I enlisted some members to make weekly phone calls. I began e-mailing a weekly newsletter and a daily Bible study on our FaceBook page. My home visits were stopped and hospital/nursing home visits were allowed only when a person was dying. Most everything became virtual and there was a steep learning curve to the technology required to be effective. It was a difficult time; it was an exhausting time; it was a sad time.

We began to see worshippers tuning in online from many places in the US and even some foreign countries. We stayed connected with our members through modern technology; we lost connection with some of our members who do not use modern technology. We lost 7 of our members who passed away in 2020: Dale Lundeen, Dennis Stanius, Renae Hooker, Dorothy Larsen, Will Remus, Philip Lundeen and David Johnson. I did an additional 20 services in the community for non-members.

I found encouragement and hope in scripture, particularly in the Old Testament. The Israelites had to deal with being away from everything they knew in the past as they traveled the wilderness. They complained bitterly; they lost faith; they sinned terribly, but God never left their side. God forgave them and took them back as His children every time. Exodus 19: 3-6 "Then Moses went up to God; the Lord called to him from the mountain, saying, "Thus you shall say to the house of Jacob, and tell the Israelites: <sup>4</sup> You have seen what I did to the Egyptians, and how I bore you on eagles' wings and brought you to myself. <sup>5</sup> Now therefore, if you obey my voice and keep my covenant, you shall be my treasured possession out of all the peoples. Indeed, the whole earth is mine, <sup>6</sup> but you shall be for me a priestly kingdom and a holy nation. These are the words that you shall speak to the Israelites."

David suffered much persecution from Saul, but he persevered and became king. From 2 Samuel 5: 10 "And David became greater and greater, for the Lord, the God of hosts, was with him."

Job suffered greatly even though he was a wealthy man of upright character who loved God. God allowed everything Job had and loved to be destroyed, but Job never lost his faith in God. He trusted God and in the end, God blessed him. Job 42: 10 "And the Lord restored the fortunes of Job when he had prayed for his friends; and the Lord gave Job twice as much as he had before."

And finally, when Jesus gave the great commission at the end of Matthew, he assured us that anything that got in our way of proclaiming the Gospel would be handled with Jesus at our side. Matthew 28: 18-20 "And Jesus came and said to them, "All authority in heaven and on earth has been given to me. <sup>19</sup> Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, <sup>20</sup> and teaching them to obey everything that I have commanded you. And remember, I am with you always, to the end of the age.

You know how many times Jesus told people not to fear. 365 is the count! Once for every day of the year. "Fear not!" We could have hunkered down and isolated completely, but being social creatures, we felt a strong desire to be back in our sanctuary. We came back together for a while, but when Covid numbers increased in our area, we were advised to close once again. We continued to worship and hold fun activities. We will return to our building; we will return to our dreams; we will grow our church; we will continue to provide ministry excellence and proclamation of the Gospel. Fear not!

Amy Crumpton wrote in Huffpost 2017

"So this morning, I prayed.

"Jesus, I'm afraid. Apparently there is a "fear not" for each day of the year, but I need one for each minute, please. And since I'm a big scaredy cat, could you please teach me about fear so I don't feel so dumpy?"

This is what I heard,

Fear is a cause to pause. An invitation to stop and seek My way forward.

I thought about the circumstances in scripture when The Lord says, "fear not." These are pivotal times when His people have paused to ask for direction and courage. They are taking big risks; facing their giants; going into battle; saying unpopular things; traveling into unchartered territory; being persecuted for their faith.



Their fear makes them stop and ask, "Lord, before we press on, is this really from You?" And The Lord says to them 365 times, "Yes. It's me." Or more precisely, "Fear not, I'm with you."

Well this was definitely a year we never could have predicted! Last year at this time we couldn't wait for our summer mission trip to the Dominican Republic – and we were working hard at fundraising and making arrangements for that trip. Now, a year later, due to a global pandemic that trip was postponed a year and we are still a little uncertain about whether or not it will happen this summer. In all of my 25 years of ministry, I have never had a year of ministry quite like this one. The beginning of the year started out fairly normal as we were making plans for our summer trip, going on retreats and hosting our annual Sweetheart Dinner. In March, as our council met for a retreat to do visioning and planning for the year, it became apparent that COVID was becoming a serious issue, and a difficult decision was made to suspend in person worship and activities. At the time I had hoped it would be short lived, although I suspected we might not be meeting in person for Easter. I still didn't quite imagine how this year would go.

We mourned the loss of many things – long time members, part time staff, in person worship and familiar events and activities like our summer trip, Summer Stretch, Trunk or Treat and the Live Nativity. We also celebrated and innovated! We found new ways to worship together in the parking lot and online. We did confirmation over zoom – including our white elephant Christmas party exchange. We delivered worship bags with Easter crafts to our young families and did our first "virtual" Christmas program putting together a very successful Christmas Eve Service for all our families that had over 24 different families/people participate in making a success! We have had virtual scavenger hunts and a Food truck fellowship night. We had a Summer Splash camp day with Camp Onomia. Members of this church helped ensure that our youth had a great parking lot "live" basket auction in place of our usual Silent Auction/Pie Social – still allowing us to raise over \$2000 for our youth program. I learned how to become a video editor and set up a "recording studio" and office in my home – there is still a lot to celebrate!

I have been continually amazed and delighted by the leadership of this congregation, specifically, by your council leadership. Believe me, there is no manual for how to lead a congregation through a pandemic. This council was called on to make difficult decisions, that were inevitably going to be hard for this congregation. People weren't always going to agree on what the right course of action was, and the council and our COVID task force had to make hard choices. The council leadership has handled those decisions with a great amount of grace and care, constantly working to make the best possible choices for this congregation, even when those choices have been difficult. This was a year of transition for both youth and education as we said goodbye to Tammy Dufeck and Jennifer Manion who served as our council chairs. I was sad to see them leave, as both of them were great assets to me as I started working here, and I was very thankful for their leadership on council. Margaret Bauer and Amanda Saelens stepped in as our new chair people in the midst of this chaos in March and have done an amazing job! I am so thankful for their partnership in ministry, and for their willingness to try new things, and figure out new ways to do things!

## MINISTRY TEAM REPORT Congregational Life



Wow, what a year it has been! 2020 started off with so much momentum and while it may not have gone how we thought it would (or even close), there were quite a few bright moments. After the world shut down in March, Congregational Life took a step back as we all figured out how to pivot our lives. A few months later, with the reopening of parking lot worship, we were able to come together again and really hit the ground running! Within one meeting we had an outdoor community event planned for July – Food Truck Fellowship.

As with any event that has gone on this year, we followed the ebb and flow of information that was available at the time and felt that we could safely host an outdoor gathering especially given the amount of available space our church has. Being honest, we had some doubts as to how many people would actually stop by on a Wednesday night, to a rural church, for dinner from food trucks, but boy were we surprised! Congregational Life was able to secure four different food trucks with two local dinner vendors (Bradford Roadhouse and Center City Swine) and two dessert vendors (Apple Cider Donuts and Snowie). We also set up spaced tables and a few lawn games for people to play when done. Personally, from start to finish, "Oh ye of little faith" a quote from Jesus mentioned throughout the gospels, rang over and over in my head.

As I reflect on this year, this phrase rings true for so many trials we've encountered. There are times I've found myself frightened or in doubt like the disciples on the boat who do not even recognize that Jesus is literally asleep right next to them. I have let fear and/or humanly emotions cloud my view point from the only thing that can provide true hope. Did that stop Him from showing up to calm the sea and settle the emotions? Not a chance and He did it over and over again.

Food Truck Fellowship was, to say the least, "well attended". The vendors were as surprised as we were! Some even ran out of food and/or had to send for more. Congregational Life's mission is to be the hands and the feet of our church and to shine our light out in to our community. That event was a great example of how we can do that. I do want to put a disclaimer in here that at the time of the event we did follow all safety and outdoor event protocol that the Minnesota Department of Health had outlined.

## Finance

**2020 COVID**... What can we say in church words? **UFF-DA** and many challenges for all of us.

As I look at the prayer list each week, I see so many of us with other health issues also. As a group of us where discussing some outside lighting and church roof problems and looked over at the Cornerstone and then at the new church. We can all look back and see the hard times the church has weathered over the past 125 + years and we can see where we are now. **"We are going to be OK" with the Grace of God.** 

Last year we had a budget of \$422,000. When the pandemic hit, we immediately took steps to reduce spending. This included reducing our mortgage payment and cutting back on other expenses. Our year ended with expenses totaling \$324,000. And thank you for your giving generosity--\$368,000 in 2020. We were able to end the black, even after paying all our bills.

We also received a **PPP loan** (with the help of Flagship Bank of Isanti) through the federal Cares Act which was later forgiven, meaning we do not have to repay the **\$28,000** which was converted to a grant. This money was used for staff payrolls and really helped sustain cash flow during the year. We introduced several changes in the **finance area** this year:

- Revised the Counting procedure so that it would be clearer to understand for new counters. Many thanks are in order to the counting team for their work throughout the year.
- Developed a new graphic to better show congregational giving as compared to expenses. You have seen this monthly report in the bulletin and the full year chart is included in this annual report.
- Reorganized the monthly Accounting Reports so that the accounts are now aligned with each council member's responsibility area. This allows them to better see their part of the budget vs. actual expenses.

As 2020 ended, the church council worked hard to develop the 2021 Budget which is included here. While there are many unknowns in front of us, we have put together a budget that reflects our best judgement for a realistic budget. This budget totals **\$366,000** and includes the payoff of our **building mortgage** before the end of 2021. Given the 2020 giving level, this should provide a balanced budget of expenses to giving for 2021.

Due to COVID, our finance team has been unable to meet in person, so we look forward to when we can again convene in person and continue working to build a strong financial future for **the building and maintenance of God's ministry and church**. If you have financial experience and are willing to serve on the finance committee, please contact me. We welcome your input and participation.

## LONG LAKE COMMUNITY CEMETERY COUNCIL

## **Annual Meeting Minutes 2020**

The annual meeting of the Long Lake Cemetery Council was called to order by Chairman/ Secretary, Greg Anderson at 3:40 PM, on December 18, 2020 at the Bradford Township town hall. Cemetery Council members present were Greg Anderson and Jim Peterson. Tom Anderson who serves as the current cemetery grave preparer/grounds keeper was also present. In addition Richard Hansen, Long Lake Church member and Wayne Anderson, Stanford Township resident were also present. It was first recognized that lifetime member of Long Lake Lutheran Church and longtime Cemetery Council member Phil Lundeen passed away on November 3, 2020. Phil had a genuine care and love for the community, Long Lake Lutheran Church, Long Lake Community Cemetery and will be greatly missed. For the past several years Phil served as Cemetery Council Sexton and with that Phil maintained the most current church cemetery records, sold gravesites and was the contact person for funeral homes and for families when someone was to be buried at Long Lake Community Cemetery. Those records were passed onto Greg Anderson by Phil's son, Tim. From those records Greg provided an updated copy of the cemetery grounds mapping to Jim and Tom. Phil's passing left a vacancy on the Cemetery Council and the Cemetery Council decided to temporarily appoint Tom Anderson, grave preparer/grounds keeper to the Cemetery Council until such time someone else is appointed as a permanent replacement to fill the vacancy which has occurred with the passing of Phil Lundeen. As a result it was agreed Sexton duties/responsibilities will be a joint effort between Tom, Jim and Greg. In addition it was noted that the December 18, 1978 Cemetery Management Agreement between the Long Lake Cemetery Association and Long Lake Lutheran Church Council indicates the Long Lake Lutheran Church Council will delegate the administration of the cemetery property to a cemetery council for which the agreement states the following regarding the cemetery council membership; "a cemetery Council which will consist of three (3) members. Of said three (3) members, two (2) members may be members of the Long Lake Lutheran Church and at least one (1) member shall be a non-member of the Long Lake Lutheran Church, but who as a interest in the operation, maintenance and management of the cemetery".

There were two revisions to the 2020 Long Lake Cemetery Council annual meeting agenda to include a presentation by Richard Hansen and to also update from last year the term for Jim Peterson. The December 27, 2019 Long Lake Cemetery Council annual meeting minutes were presented by Greg Anderson as an attachment to the 2020 Long Lake Cemetery annual meeting agenda. Those December 27, 2019 minutes were approved as written during the annual 2020 congregational meeting.

Greg Anderson reported from what he can determine from Phil Lundeen's records and Tom Andersons recollection of burials that for 2020 there were 4 grave sites sold, 10 burials (6 were cremations) and an estimated 167 grave sites, not including walkways, remaining on the east side one-acre of the cemetery available for purchase. It was also noted that more research on possible gravesite space designated for cremations is needed on the original west one-acre.

The estimated Certificate of Deposit (CD's) balance (11/30/20) is \$48,500.00 of which \$916.52 is interest earned. There are 5 CD's and four are set to expire in 2021 and one in 2022. Unless directed otherwise the CD's automatically renew at the end of their current expiration date.

Greg reported in regards to last year's audit it was recommended more clarity be provided when specific deposits were made into the Cemetery account such as a name associated with a sale of a grave. As a result the cemetery Council agreed more coordination between the treasurer and whoever received payment for a gravesite needed to occur.

As Grounds Keeper, Tom Anderson agreed to continue to maintain (mow, trim, weed whip, etc.) the cemetery grounds in 2021. The Long Lake Cemetery Council agreed to set the 2021 maintenance reimbursement at \$3,250. The Cemetery Council agreed Jim Peterson will provide Long Lake Lutheran Church enough advance funds in order that the Church can make six monthly disbursements of \$500 and one \$250 monthly disbursement to Tom for the 2021 maintenance of the cemetery. As Grave Preparer, Tom Anderson agreed to continue with the grave preparations. Tom reported no real issues in 2020 with the cemetery maintenance or grave preparations but he may need some assistance with grave preparations during winter months, especially when there is a deep frost in the ground.

## LONG LAKE COMMUNITY CEMETERY COUNCIL Annual Meeting Minutes 2020 (page 3)

It was noted that Jim Peterson's term runs from 2020-2022 and will continue as Treasurer for 2020. Phil Lundeen's term ran through 2021 and it was decided to temporarily appoint Tom Anderson to fill that term. Greg Anderson's term expires in 2020 and was reappointed for another three year term (2021-2023) and will continue to serve as Chairman/Secretary for 2021.

Richard Hansen who serves as Sexton for Nichols Cemetery provided information as to the method he uses to maintain cemetery records and documentation he provides when there is a gravesite sold. The Long Lake Cemetery Council agreed to adopt similar methods/practices so that matter will be pursued further.

At last year's annual meeting Greg Anderson provided the Cemetery Council with an on-line Long Lake Cemetery Directory proposal submitted by Dave Larson as well as information from a Columbarium he viewed at St. Stephens Lutheran Church in Bloomington, MN. At this year's annual cemetery council meeting further discussion occurred regarding the need of an on-line directory and as a result the Cemetery Council agreed to approve up to \$5,000 be allotted to accomplish this task. During last year's on-line directory discussion the Cemetery Council felt a slight version of the Dave Larson Proposal #2 would be most practical. With that proposal Dave prepares a PDF file with all the headstone and unmarked grave information. If Long Lake Church staff does not have the time to load the information into the Church Web Site then Dave Larson is hired to complete that process. In addition the Cemetery Council felt that on a yearly basis Dave Larson could be hired to provide updates to the on-line cemetery directory since there are usually a minimal number of burials occurring and headstones placed in Long Lake Cemetery during the year. The Cemetery Council also felt the columbarium project is something that Long Lake Church needs to pursue. Greg explained Pastor Sue did have the columbarium matter included in the Church property study which has been completed. The Cemetery Council also discussed the future status of the Long Lake Cemetery Council and concluded it would be best to continue to maintain a Long Lake Cemetery Council.

The current Long Lake Community Cemetery fees and policies are as follows:

The initial cost of a gravesite is \$400 and:

-One gravesite can contain one vault and one additional cremation

-Two cremations are allowed when there is no vault

Note: More than two cremations (up to a total of six) may be allowed within one gravesite under the coordination, review and supervision of the Sexton/Grave Preparer. However, the Council agreed there would be no more than a total of two grave stones allowed.

For example: one head stone and one foot stone and if there are multiple cremations the head stone would contain all the names of those buried within the grave site. The Council agreed up to an additional \$125.00 for each cremation may be assessed.

Also, additional fees are charged beyond the initial cost of the \$400 gravesite fee/\$125.00 cremation fee for the various expenses associated with preparing (which can include such activities as locating, marking, snowplowing, thawing, digging and covering, etc.) the gravesite. There was also discussion for the need that some additional headstones may need to be lifted. During last year's annual meeting Tom Anderson reported one of the older slate upright headstones on the west side of the cemetery needs to be repaired. The Cemetery Council agreed to make no changes with either the cemetery fees or policies for 2021. However, Jim Peterson noted since a total of 6 cremations are allowed in one gravesite perhaps more than the two gravestones should be allowed. It was decided to address this matter further in 2021.

Greg Anderson also reported on the September 3, 2020 correspondence received from Parker Satrom Law, P.A. in which notice is given that Long Lake Lutheran Church Cemetery Fund, Isanti, MN is named as one of several recipients of a charitable gift of funds to be used as directed by the governing body of the organization which is this case would be the Long Lake Cemetery Council.

The 2021 Long Lake Cemetery Council annual meeting will be scheduled for a date, time and location at the end of 2021. There being no further business the meeting adjourned at 5:40 PM.

2020 Audit Committee

January 10, 2021

The Finance Team held a meeting for the year-end audit of 2020 on January 10, 2020. The Audit Team consisted of Bruce Riebe and Bruce Yurich. In attendance for document information and support were Dennis Wanless, Treasurer and Finance Team council representative and Jennifer Sonterre, Business Administrator.

Due to COVID protocols, some of the audit process was conducted electronically which allowed for safe distancing practices to be followed.

The scope of the audit included:

<u>LLLC Checking</u>: Randomly selected 6 transactions from the detailed General Ledger and verified that all documentation (check copy, approval green sheet, related invoices/receipts and sign-offs) supported the transaction without exception.

<u>LLLC Contributions</u>: Randomly selected 2 deposits and recalculated the totals by fund and tied to the Count Summary Sheet and then matched the count sheet to the deposit on the bank statement and to the General Ledger.

<u>WELCA</u>: Randomly selected 3 checks and tied them to the check register, treasurers report and bank statement without exception. Two deposits were also randomly selected and verified to the bank statements.

<u>Benevolence</u>: The entire 2020 checkbook (both checks and deposits) was reviewed and balanced to the check register and bank statements without exception.

Note—The Finance Team will develop a policy and procedure document for the Benevolence Fund to help with future audit questions. This was not accomplished during 2020 due to the COVID circumstances.

Cemetery Fund: The cemetery account was balanced to bank statements without exception.
