Angie Spartz suggests that the committee should meet later to discuss this. Dennis Wanless recommended that we discuss this with Bruce's committee and come up with a budget. Matt Lundeen states that \$6,000 is the bare minimum, and we will probably need more. We should gather again to discuss this. Marsha made a motion to table this.
- 11:33 am Marsha Weidner had a question about organist substitutes being a separate line item. Matt Lundeen stated we can't make a decision about this right now, Dennis Wanless agreed. Jennifer Sonterre brought up the difference between employees who get W2s and others who get 1099s.
- 11:38 am Donna Larsen wants money set aside for Live Nativity. We need to deal with budget motion first.
- 11:41 am Bruce Yurich calls for motion to be approved. Motion for budget voted down.
- 11:41 am Donna Larsen made a motion to increase Live Nativity to \$2,500. Becky Agranoff seconded. Motion approved. This will be a line item under Missions.
- 11:44 am Dale Findell moved to give pastor \$5,200 from General Fund to the Benevolence Fund. Bob Johnson seconded. Benevolence Fund motion approved.
- 11:46 am Marsha Weidner moved to transfer \$55,000 from General Fund into reserve fund. Bruce Yurich seconded. Motion approved.
- 11:48 am Marsha Weidner moved to increase our support of Jim Werronen from \$6,000 to \$7,200. Ronda Fenlon seconded. Motion approved.
- 11:51 am Matt calls to approve budget. Matt stated we need to increase trash removal to \$600. Alli Rock makes a motion to approve an increase to the budget of \$4,000, Bob Johnson seconded motion. Motion carries.

God's grace, peace, and hope be with you through our Savior, Jesus Christ.

I begin by sharing my profound gratitude to you – for your faithfulness, perseverance, and compassion revealed in countless ways during this global pandemic, now nearing the start of its third year.

As I reflect on the ministry of our synod in 2021, I am surprised to discover a number of "firsts" – something I did not expect in a pandemic year. In 2021:

- We received an unprecedented \$285,000 gift to provide educational debt relief to synod rostered leaders who are Black, Indigenous, and People of Color (BIPOC). Currently, 12 percent of rostered leaders serving synod congregations are BIPOC, a sign of growth which will be strengthened by this gift.
- With our first ever million-dollar grant from the Lilly Endowment, we called Nick Tangen and Maya Bryant to lead our <u>Faith and Neighboring Practices</u> program, currently working with 13 congregations.
- In October, we set a goal to **raise \$500,000 in three months** to partner with our global companion synod in launching the first ever <u>Lutheran University in Nigeria</u>. As of this writing, we have \$298,000 in gifts, \$56,000 in pledges, and are awaiting word about a significant gift from the ELCA World Hunger Program!
- We rejoiced with Alleluia! Lutheran Church in St. Michael as they dedicated their brand-new church building. We have celebrated many remodeling projects in our synod, this was the first completely new structure built in more than ten years.
- We welcomed Holy Cross Lutheran Church, originally a Missouri Synod congregation, into the synod.
- Led by VP Felecia Boone and Eric Howard, a task force has been working to apply a racial equity lens to the way our synod distributes funds and utilizes resources.
- We helped launch the <u>Center for Leadership and Neighborhood Engagement</u> (CLNE) led by Rev. Kelly Chatman. CLNE convened a virtual prayer tent for 77 straight days during the trial of Derek Chauvin. Now, they host "Come Together," a virtual conversation on the third Thursday evening of each month.
- We held our first <u>Zoom Synod Assembly</u> with speakers Dr. Drew Hart and Michael Osterholm; offered our first online <u>Tool Kit</u> (to be expanded in 2022); and provided four online worship services to provide respite and build unity across the synod.
- Listening to the weariness of our rostered leaders, we cancelled Bishop's Theological Conference for the first time and organized the whole staff in a caring process for our leaders, "Tending Weary Souls."
- We are preparing to host the <u>ELCA Youth Gathering</u> the first ever held in Minneapolis, July 21-28, 2022.

Though a list of "firsts" can make for an interesting annual report, the ministries that continue day-in and day-out are the work that sustains. We are blessed with over 675 rostered leaders, 307 serving in calls and 370 retired or without call. In 2021, we supported 57 persons preparing to become deacons or pastors. We work hard so the church has the loving, faithful, and theologically well-formed ministers it needs.

Our monthly conference meetings and other synod gatherings continue to reveal a real hunger for leaders to stay connected and discern best practices for ministry in these times. We are honored and humbled by our calling to serve as convener of such holy conversations.

It is the generosity of congregations like yours that make the synod's work possible. Thank you! We seek to be careful stewards of every gift.

A year of firsts. More importantly, we gather around the unique, first-ever, Word made flesh – the Christmas miracle of God becoming human for us and our salvation. And even more, this Word made flesh abides with us – through all our firsts and lasts and everything in between.

Gratitude is powerful. Theologian Lewis Smedes recalls how he felt when he realized that he had survived a life-threatening illness: "I was seized with a frenzy of gratitude. Possessed! My arms rose straight up by themselves, a hundred- pound weight could not have held them at my side. My hands open, my fingers spread, waving, twisting, while I blessed the Lord for the almost unbearable goodness of being alive on this good earth in this good body at this present time. I was flying outside of myself, high, held in weightless lightness, as if my earthly existence needed no ground to rest in, but was hung in space with only love to keep it aloft. It was then I learned that gratitude is the best feeling I would ever have, the ultimate joy of living."

While you may not feel the elation that Dr. Smedes experienced, gratitude can be transformational. Giving thanks to God each and every day can bring you feelings of wonder, awe, joy, love, and you may feel more in tune with the world and your self. I am grateful to God every morning when I wake up. *"Thank you, God, for another day, to serve you, to love your people, and to experience your presence."* I am grateful to God for His calling and equipping me for ministry; I am grateful for my calling to this church to serve you. I am grateful for my warm house, for good food, for my loving family, for friends, for my car, for books and my ability to read and think, for my view of the Rum River, and for a land that produces beauty beyond measure. What are you grateful for and how does that impact how you live your life? I invite you to intentionally take time to ponder the gifts God has given you, the abundance God has blessed you with, and the beauty that surrounds you. Take time to ponder, then give thanks. May you feel that ecstatic rise of emotions like theologian Lewis Smedes did when he survived his illness.

We have survived some challenging times at Long Lake Lutheran. While we were filled with excitement for visioning and growth, the world began to shut down and close in on us as we faced the continuing implications of a global pandemic. Sometimes it has felt like paddling upstream with just one paddle, or like how I felt I went through the Ranier Rapids backwards in my canoe a long time ago. Scary, unsettling, jarring, hopeless, fearful, and exasperating are words that come to mind. I have prayed for God's guidance over and over; I have prayed for God's deliverance from this awful illness that just won't go away. I believe God hears our prayers. We have managed to continue to worship indoors, outdoors, online, with and without sound, sometimes socially distanced, putting our fellowship and other activities on hold, yet we continued to pay our bills, pay off our mortgage, and build up our reserves. God has got us! We are faithful to God and God is faithful to us. For all of this we must be grateful.

While some of our activities were curtailed, we still managed to take a van full of people to see

We are grateful that she and her helper Thomas deep cleaned our buildings so wonderfully. I am grateful for the collegiality of Shawna along with her experience in Youth and Family Ministry. I am grateful for our musicians who share their gifts with us. I am also amazed and so very grateful for all of the volunteers who do so many things for this church and for our faith community. All in all, we have a lot to be grateful for.

Well, here we are, celebrating another year of ministry at Long Lake Lutheran Church. We have proven to be resilient! We began this year still meeting online, and in the parking lot. We had to continue to innovate and find new ways to do things that we have done before, things that had become important traditions to us. In February we hosted a "drive up" Sweetheart Dinner, which was very successful. Due to continuing concerns about COVID, and about how it would affect international travel, we had to "pivot" and made the decision to change our mission trip to Dominican Republic to a Domestic Trip to Alaska. Despite the change, all the original members of our trip chose to still go (except one who had moved away) AND we added a few more to our group! Instead of an Easter Breakfast, we hosted an outdoor chicken dinner that was a lot of fun. Education and Youth was able to begin meeting in person a little this spring for the end of our programming year with specific protocols in place. Your faithfulness made that happen.

This summer we were able to take fifteen people on a mission trip to Alaska through Praying Pelican Missions. This congregation supported them financially, and through prayer and letters while they were on their trip. While we were there, we served the community of Fairbanks Alaska on behalf of Long Lake Lutheran by working in soup kitchens, reclaiming wood to go to remote villages in Alaska, serving the homeless and learning more about the wide variety of cultures and places that make up Alaska. Your faithfulness and support made that happen.

We sent children to camp at our partner camp, Camp Onomia, and hosted VBS, and then this fall we begin education and worship in person. Although we have begun meeting in person, we know that there are still many that not yet returned, for a myriad of reasons. Some of them are still joining us in the parking lot, or online. We are thankful for the return of some sense of normalcy, but we still know that we are not quite there yet. There is still anxiety for many people. Illness and quarantine still interrupt our lives, and has affected many in this congregation, yet your faithfulness and support continue to move through this place and shows us that God's spirit is at work.

There are signs that give us hope! Several new families with young children have joined Sunday School, and our enrollment numbers in Sunday School have increased. The education team had worried as numbers, especially on Sunday morning had been down, and now they are climbing again. We had a wildly successful trunk-or-treat with over 550 children in attendance! We added a magician and teamed with congregational life for the bonfire, and it was a great day. Our recent Christmas program combined music and photos for a great retelling of the Christmas story.

We said goodbye to Jen Sonterre, who has been a fantastic asset to this congregation over the years. We welcomed Rachel in her new role, and she has been doing a great job.

Personally, this has been a challenging year for me, I have faced illness and a hospitalization in June, and then an unexpected surgery in November. My son was also injured and required extensive surgery. After accumulating over 15,000 in medical bills (just my portion!), this congregation surprised me with a benefit. I am beyond thankful for the ways this church has supported me and my family through this, and how they have continued to pray for my dad in his cancer journey.

Trying to make the best decisions for the congregation, when everyone has different opinions during a pandemic is not easy. In addition, we had staff changes, and unexpected staff illnesses thrown at them. Please thank them for all the work they do on behalf of this church. She loves this church, and I am thankful to have collaborated with her in ministry, as I consider it a blessing.

In 2022, I hope we work together to invite others into ministry together with us and work to figure out how we continue to honor and do the things we hold dear, and do some new things in the years to come.

Finance

I said last year, we are going to be OK with the grace of God and we are... thanks to all of you. As you see in the graph, giving was very close to the expenses we had in 2021. We worked together to reduce costs and yet do the things we needed to do to keep our church in good health.

Financially we are strong with \$216,000 in reserves as we begin 2022 and we no longer have a mortgage payment. What a great day that was when we made that last payment!

Other financial accomplishments this past year include:

We saved \$2,500 on an annual basis by re-bidding our insurance coverage package. And we were able to increase our insurance coverage at the same time.

We saved \$30,000 on a 6-year contract for our copy machine, which is \$6,000 annually.

Thanks to everyone who helped make this possible. It was done with many people with a gentle hand to guide us on the finances and a great congregation to support us.

As we look forward to the future, we will face some of the same challenges as the past 125 years of building "our church."

Please help us by all working together to help our church move into the future.

EXTENDED MINISTRY REPORT Visioning/Planning Team

2020 Visioning was introduced to the congregation towards the end of 2019. We were off to a great start in 2020 with looking back at history, evaluating our property, and looking ahead to the future. We began gathering with interested individuals, to look at our successes and challenges; we considered the Ministry Site Profile Statistics; we looked at the phase 2 plan from the previous visioning team; we discussed what God is calling Long Lake Lutheran to do and what changes were necessary to help us respond most faithfully. We ran a few surveys and polls; we asked, and we listened to as many people with whom we could connect. A Vision Plan for 2021 and beyond was created. We were on a roll!

2022

Of course, everyone knows what happens to well laid plans. God gently laughs when humans make plans! The Covid-19 Global Pandemic hit, and the church building was temporarily closed. Our planning was put on hold.

Here we are, at the beginning of 2022 and we are still in the visioning/planning phase. We still have interested people coming to meetings and are always hoping more will join. We need modern education space along with a large gathering space and more storage. We have looked into the costs to renovate the Cornerstone (old church) and they seem to be quite high due to asbestos and lead abatement, elevator costs, updated plumbing, electrical, technology, heating, cooling, and sprinklers. We, as a congregation, have to decide how much money to put into an old building that we currently only use 6-10 hours/week for education and 6-8 times a year for Mission Quilting. The options are: to renovate, to tear down, to retain/restore small chapel and bell tower, to move it off property, try to find other uses, to patch it up.

The most recent meeting was with the Isanti Fire District, Fire Chief and the Isanti County Building Inspector. Isanti county will not consider a building permit for remodel or for demolition of the cornerstone without submitting an environmental building survey that identifies hazards like asbestos and lead paint. A separate permit is required for the abatement to be completed and inspected first. Patching the Cornerstone would take more money than most people assume. We will move forward with the Environmental Survey. Aside from the Cornerstone issue, an addition could be built on the West end of the current building, which would include a multi-function great room that could host larger events, storage, bathrooms, kitchen. Outside access could lead to a Columbarium (a holy resting place for urns), playground, fire pit, outdoor worship area. Additions could go on the North or East sides as well.

Looking ahead to the future, Long Lake Lutheran Church would like to continue to provide meaningful spiritual experiences to anyone coming through our doors, remain relevant to the community, attract young families, provide access for individuals with handicaps, and meet the needs of the community for gathering space. How we do that will take a lot of committed people, a fairly significant amount of money, including a capital campaign to raise funds, and would take place over a two-three year period.

The next steps after the Environmental Survey are to get a qualified church architect to begin some schematic designs and renderings for conversation. Please note: we do not have a building plan or capital campaign in place; we are still in the dreaming and talking phase.

It is pretty amazing that we paid off the mortgage on the 2000 building in 2021. Being debt free feels great, but is not great if we are unable to provide relevant experiences for today's youth. We cannot remain in the past; we cannot return to the past; we cannot sit still. Do you know what happens when you are riding a bike and you quit peddling? Right! You fall over. Keep peddling for God!

Annual Meeting Minutes 2021

The Minutes of the 2021 Cemetery Council Annual Meeting

2022

The annual meeting of the Long Lake Lutheran Church Cemetery Council was called to order by Chairman/Secretary, Greg Anderson at 5:30 PM, on December 30, 2021 at the Bradford Township town hall. Cemetery Council members present were Greg Anderson, Jim Peterson and Bob Johnson. Tom Anderson who serves as the current cemetery grave preparer/grounds keeper was also present.

The December 18, 2020 Long Lake Cemetery Council annual meeting minutes were presented by Greg Anderson as an attachment to the 2021 Long Lake Cemetery Council annual meeting

agenda. The December 18, 2020 minutes were approved as written during the annual 2020 congregational meeting.

Bob Johnson was elected for a three year (2022-2024) Cemetery Council term and agreed to continue as Cemetery Sexton for 2022. Jim Peterson whose term runs through 2022 agreed to continue as Cemetery Council Treasurer for 2022 and Greg Anderson whose term runs through 2023 agreed to continue as Cemetery Council Chair/Secretary for 2022.

As Sexton Bob Johnson reported there were 14 burials in 2022 of which 10 were cremations and 4 were casket burials. Bob also reported 5-lots were sold and that there are 138 gravesites

available for sale along with 35 aisles.

As Treasurer, Jim Peterson submitted the following written financial report as of November 20, 2021: Checking Account:

It was noted 4 of the 5 certificates expire in 2022 and the current interest rate is minimal. Discussion took place regarding banking institution options and Greg Anderson noted the December 18, 1978 Cemetery Management Agreement states that the perpetual care fund shall be maintained at the First Bank of Isanti, Isanti, Minnesota or such other Bank as the Cemetery Council shall determine. The Cemetery Council also discussed that unless directed otherwise the certificates expiring in 2022 will automatically renew at the end of their current expiration date. It was also noted the monetary gift from the Lee Estate was deposited in a savings account at FlagShip Bank and the Church's annual audit will take place in January 2022.

As Grounds Keeper, Tom Anderson agreed to continue to maintain (mow, trim, weed whip, etc.) the cemetery grounds in 2022 for \$3,250. Therefore, the

Cemetery Council agreed to set the 2022 maintenance reimbursement amount at \$3,250. The Cemetery Council agreed Jim Peterson will provide Long Lake Lutheran Church enough advance funds in order that the Church can issue six monthly disbursements of \$500 and one \$250 monthly disbursement to Tom for the 2022 maintenance of the cemetery. As Grave Preparer, Tom Anderson stated he no longer wanted to prepare graves during the winter and will make a decision about the spring/summer months. Therefore, the Cemetery Council agreed they would make arrangements to have someone else prepare gravesites for the winter months. Tom reported no major issues in 2021 with the cemetery maintenance or grave preparations other than some reseeding may be needed.

The current Long Lake Community Cemetery fees and policies are as follows: The initial cost of a gravesite is \$400 and:

- One gravesite can contain one vault and one additional cremation -Two cremations are allowed in one gravesite when there is no vault

Note: More than two cremations (up to a total of six) may be allowed within one gravesite under the coordination, review and supervision of the Sexton/Grave Preparer and up to an additional \$125.00 for each cremation may be assessed. Current policy is no more than two grave stones are allowed per gravesite. For example: one head stone and one foot stone and if there are multiple cremations the head stone would contain all the names of those buried within the grave site. However, the Cemetery Council did discuss further the issue of multiple gravestones on a single gravesite where more than one person is buried. Also, additional fees are charged beyond the initial cost of the \$400 gravesite fee/\$125.00 cremation fee for the various expenses associated with preparing (which can include such activities as locating, marking, snowplowing, thawing, digging and covering, etc.) the gravesite. No changes with either the cemetery fees or policies for 2022 were made.

It was agreed additional Veterans grave markers should be purchased and that Bob, Jim and Greg will arrange for placing flags on Veterans graves for the 2022 Memorial Day. Also, it was agreed an effort will be made to determine if there are any lot markers currently existing in the ground on the open gravesites. It was also noted there are some existing headstones in need of lifting and/or repair. Greg Anderson provided an update on the Columbarium in that it was one of the items listed in the Long Lake Lutheran Church Visioning documents and that he is still working with Church leadership and administrative staff with creating an on-line Cemetery Directory.

LONG LAKE BENEVOLENCE COMMITEE

Members: Pastor Sue, Jessica Larsen, Phil Maguire, Nate Dufeck

A committee was formed, upon the recommendation of the audit team, for oversight of the Pastoral Discretionary Benevolence Fund. This is a separate checking account that is used for the purpose of assisting people needing help with rent, utilities, car repairs and food support. Many people contribute to this fund through cash donations or through their offerings. WELCA offers support by purchasing County Market gift cards that can be used for food or gas. These are given to people who call and request them. Only one request per person per month is allowed; a driver's license is required and a copy is filed. These people are also shown where the food shelf is located and are allowed to pick up as much food as they wish without any requirements. Bakers Acres also offers us fresh eggs to give to those in need. The committee is contacted quarterly with updates on what has been spent and is contacted when a larger request comes in. It is still at the Pastor's discretion, but is guided by the three members.

LONG LAKE MEMORIAL COMMITEE

Members: Pastor Sue, Merwynn Larsen, Ali Rock, Monica Ahlman

A Memorial Fund Policy was established and approved by the Finance Team. Money given specifically for memorials will be tracked and placed in a separate fund. Ideas for memorials were generated by each congregational team. They include: a flagpole to honor Will Remus and all Veterans by the softball team and already funded by the Remus family. Bleachers provided by the Dale Lundeen memorial. Friends of Ruth have asked for new books for the kid's busy bags. Other ideas include: a playground, fix the cross on the Cornerstone, new furniture and TV for the Youth Room in the Cornerstone, scholarships, technology improvements, Youth Gathering sponsorships, Leadership Training such as the Council Retreat expenses, sound equipment, altar flowers, books for the church library, coffee fund, kitchen fund, property upkeep and landscaping, memorial garden, building fund, etc.

A Memorial book was purchased to record memorials given and what is purchased with the memorial money. Thank you notes and tax letters are sent for gifts over \$250 and by request. A Memorial Brochure will be created this year that will list the ideas and needs of the committees outside of their budgets. All ideas are welcome; the Memorial Policy is available upon request. All memorials are welcome, no matter the size. This is a wonderful way to remember your loved ones.

FINANCIAL REPORTS

Long Lake Lutheran Church Audit Report (page 1)

In the review of the 2021 financial transactions, reports, and procedures, the Audit Committee makes the following recommendations.

- Check signers be limited to members of council that do not have specific committee assignments/budget lines. This will remove actual or perceived conflict of interest by separating the authority to approve expenditures on behalf of the church from those individuals who sign for the payment of approved expenditures.
- More members of the council participate in signing for authorized church expenses. It was noted that an unusual number of payment authorizations are documented with the Treasurer and Property council member's signatures. While this does meet the procedural requirement of two council member signatures it does raise the likelihood of appearance of conflict of interest in proper controls over church finances and expenditures.
- The Treasure should not serve as a member of any select ministry team. In interviews with those attending the audit it was noted that some ministry teams include the Treasurer as a member of the team. While this is a commendable willingness to volunteer, it is recommended that this not continue due to the appearance of conflict of interest as the Treasurer establishes the church budget and oversees all finances. This can be interpreted by the congregation and other council members of preferential treatment to ministry teams in which the Treasure also serves as a member. Another mitigation would be for the Treasurer to be a member of every ministry team.

The CPA should receive council minutes after each meeting to ensure any authorized expenditures or financial decisions are documented by official church action. In interviews it was noted that the contracted CPA has not received church Council meeting minutes for the past few months.

- In interviews with the contracted CPA, it was noted that there is a lack of a communication between the Treasurer and the CPA. This has been mitigated by financial procedures and regular communication between Church office staff and the CPA. It is recommended that the Treasurer establish regular communication with the contracted CPA for the purposes of distributing financial information and providing feedback that would assist in the management of church finances.
- The CenturyLink account be updated to account for any identified service changes. It was noted
 that the internet and phone service from CenturyLink is still active and thus incurring a charge to
 the church every month. It is recommended that this be reviewed to determine if the internet
 service change to Verizon is stable and working as expected and if the phone line supplied to the
 church is still needed.
- All church Amazon purchases be only authorized using the official church account. In interviews
 it was noted that the church has an Amazon account that is available and linked to the church
 credit card for official church purchases. However, it was noted that this account is not always
 utilized for Amazon related purchases and the church credit card is still used on non-church
 owned Amazon accounts. Implementing this recommendation will ensure all purchases are
 done using the church's tax identification number and do not incur tax. It will also protect the
 use of the church credit card for non-authorized purchases or possible fraudulent activity and
 will centrally document all purchases with receipts under one account for validation.

Separate church credit cards be issued to each authorized user. It was noted that several
members of church staff utilize the church credit card for procurement of goods. Due to the
number of authorized users of this card and the nature of the "green slip" approval process
occurring after a purchase has already been completed and the monthly statement has been
received, separate cards will allow for better tracking and management of the use of the card
and will also more quickly identify unauthorized use.

2022

- The credit card policy be made available to church staff and authorized council members. It was
 noted that office staff were not aware of the existence of a church credit card policy. If the
 existing policy cannot be found it is recommended that one be created to manage appropriate
 use of this payment method.
- A church account be set up at frequently used vendors. This will minimize the number of requests for personal reimbursement from the church for purchases, centralize the reporting of church purchases from each vendor, and maximize the church's tax-free status.
- Implement the 2020 Audit recommedation regarding record keeping of the Benevolence Checkbook. It was noted that this audit recommendation did not appear to be resolved as the 2021 Audit experienced difficulties in reconciling to bank information due to lack of submitted documentation. The 2021 Audit also recommends implementing an electronic means of tracking Benevolence Checkbook activity to ensure all tracking is centrally located and reduce the need for manual calculations making future audits easier to complete.
- Transfer the \$500 Benevolence gift that exists in the Dedicated Giving account to the Benevolence Fund in 2022. It was found during the audit that a \$500 gift to the Benevolence fund was deposted into the Dedicated Giving account and was not transferred to the Benevolence fund.
- Changes in official policy or procedure be documented as quickly as possible and placed in the
 office operating manual to ensure smooth transition in the event of staff turnover. In interviews
 with church staff, it was noted that onboarding process in regard to financial procedures was
 difficult. This was linked to out-of-date procedures in office documentation due to changes over
 time. This caused confusion and delayed the effectiveness of processing and managing church
 payments.
- Modernize the "green slip" process to allow an option to use electronic means to approve a
 payment. In interviews it was noted that due to the evolution of mobile and remote capabilities
 of council members along with the unpredictable nature of the COVID-19 pandemic resulting in
 quarantine, sickness, or other needs to isolate ithe "green slip" process should be modernized to
 allow an option to use electronic means to approve a payment.
- It is recommended, as part of modernizing the "green slip" process, to require one of the two
 required signatures for a payment over \$100 be the council member that manages the budget
 line item the payment will be made from. It was noted in interviews during the 2021 audit green
 slips were signed by whichever council representatives were available to meet the procedural
 requirement. This has the potential to result in a lack of oversight or awareness of expenditures
 by those responsible for individual budgets.
